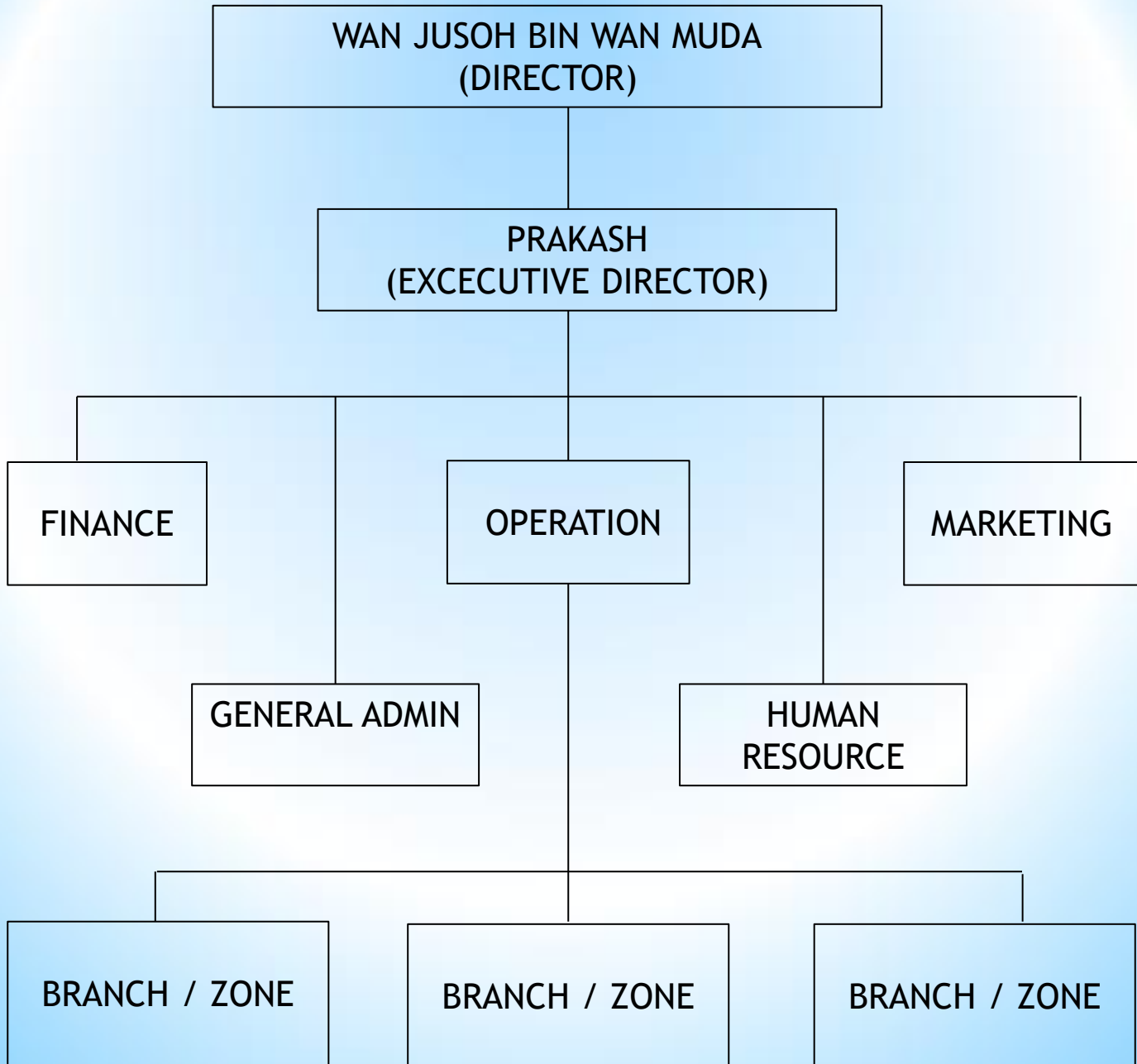

ORGANIZATION CHART



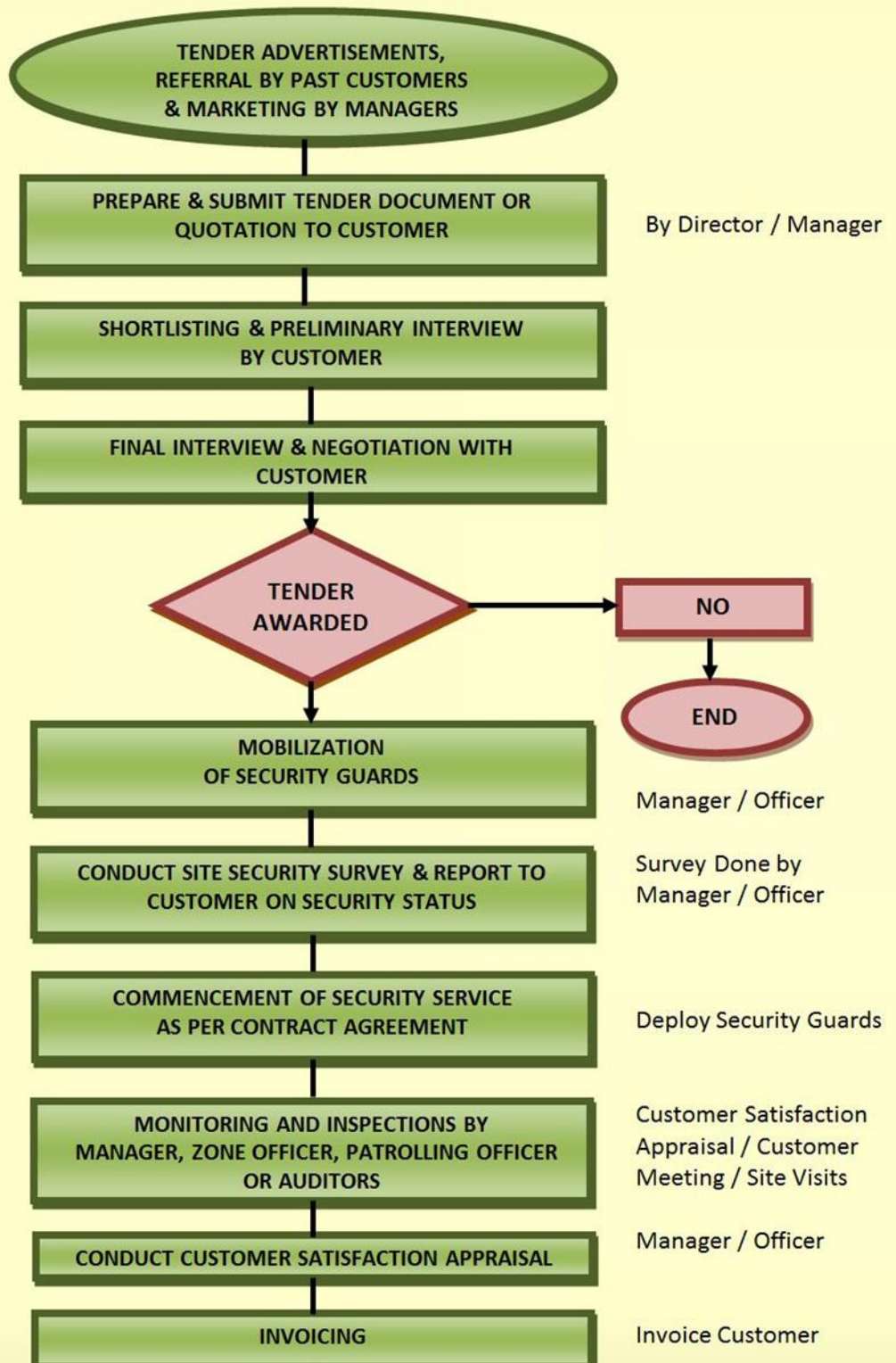
